

Royalty Expectation Statement & Code of Conduct

I understand that if I am awarded the title of Cave Creek Rodeo Days Princess, I will be a representative of Cave Creek Rodeo Days (CCRD) which is produced by the Cave Creek Rodeo Days Organization (CCRD). I cannot be a Princess for any other organization or entity once I accept this title. I will give up all other titles that have not ended prior to February 1st of the reign period.

I will strive to represent sportsmanship with high moral and ethical character. This title recognizes a number of attributes: sportsmanship, personality, public speaking and appearance. Therefore, it is my responsibility, as Cave Creek Rodeo Days representative to act, speak, and dress according to the presence my title requires any time I am in the public eye.

If I become the Cave Creek Rodeo Days Princess, I Will:

- Wear my crown and sash any time I am acting in the capacity as Cave Creek Rodeo Days Princess.
- Make myself available for all opportunities to appear as Cave Creek Rodeo Days Princess to the public.
- Be on time. No one should have to wait on you.
- Not use foul language, or chew gum in public while acting in the capacity as the Cave Creek Rodeo Days Princess.
- Remember the last thing you do is what they will remember. First impressions are important and last impressions are forever.

Dress Code Requirements:

- Cave Creek Rodeo Days Princess must adhere to PRCA arena dress codes when in a rodeo arena.
- Clothing should reflect a professional western image. Try to wear the shirt color for the rodeo theme of the performance when applicable (e.g., pink for Pink Night).
- Dress or skirt no shorter than 2" above knees.
- No sleeveless or tank tops, open back or bare midriff and at no time should bra straps be visible.
- Hair is to be styled fashionably. Pony tails or braids are acceptable alternatives; however, hair must be styled. Keep fingernails clean and pay attention to makeup, don't over do it.
- Keep hats clean and well-shaped and keep boots clean and free of mud.
- Sashes: clean and pressed. Carry pins for your sash at all times.
- Jeans: clean and preferably ironed.

Cave Creek Rodeo Days Princess Rules

- 1) Applicant/Princess must have a signed contract between her parent or legal guardian and Cave Creek Rodeo Days including Royalty Expectations, Princess Rules and the Waiver of Liability.
- 2) Applicant/Princess is not permitted at any time to represent the Cave Creek Rodeo Days or wearing the Cave Creek Rodeo Days Crown or Sash at any event without approval of the Royalty Committee Chair or the Cave Creek Rodeo Days Board of Directors.
- 3) Applicant/Princess understands this is a volunteer, unpaid position with the Cave Creek Rodeo Days Organization.
- 4) Applicant/Princess must conduct herself in a professional manner; portray high moral standards, good sportsmanship, be supportive and respectful of others.
- 5) Applicant/Princess will provide their own transportation to and from all activities.
- 6) Applicant/Princess must be aware of and conform to PRCA dress code (long-sleeved shirts, western jeans, hat, and boots). Western attire is required when representing the Cave Creek Rodeo Days.
- 7) Applicant/Princess is not permitted at any time to drink alcoholic beverages, smoke, use drugs, or use foul language.
- 8) Any problem that may arise should be quickly directed to the Royalty Committee Chair or the Board of Directors.
- 9) Parents, friends, and relatives are welcome to attend all events. Appropriate language and respect of others will be displayed at all times throughout the reign.
